Breakfast with Santa is an annual event held at Camp Fire Camp El Tesoro outside Granbury. The event features camp activities, free Santa photos, and the option to purchase breakfast.

Attendance has varied: 2021=215, 2019=450, 2018=580

Any vendor wishing to participate in Camp Fire's Breakfast with Santa and Holiday Market must submit an application along with the booth fee, at least five (5) business days before the event or until Camp Fire has accepted its maximum number of applications.

Applications will be reviewed to determine family appropriateness and to limit the number of similar products being exhibited. Space is limited. Applications will be approved on a first-come, first served basis. If an application is approved, Camp Fire will notify the vendor.

The Vendor will rent a space from the Camp Fire Holiday Market at Camp El Tesoro located at 7710 Fall Creek Hwy, Granbury, Texas 76049 on Saturday, December 3, 2022.

Set-up must be completed by 7:45 a.m.
Event runs from 8 am - 11 a.m.
Tear-down ending at 12:00 p.m.

Camp Fire will provide 1 table, 2 chairs, and (optional) electricity. The Vendor will provide all decorations, cables, canopy and equipment necessary to run the booth.

The Vendor agrees to abide by the following guidelines:

- Gate code will be provided the day prior
- Vendors can drive in to set up booth, but cars need to be taken to the parking lot by 7:45am
- Restrooms will be available to use.
- Limited indoor space. First paid spots will claim them.
- The Vendor takes responsibility for any damages or incidents that occur at his/her booth.
- The Vendor attests that all his/her products are his/her property, and are associated with his/her business.
- The Vendor will not sell illegal or inappropriate material at this event.
- The Vendor will be responsible for any required permits, licenses, or taxes required by the county or state.
- Camp Fire is permitted to take photographs of the booths and vendors and use these photographs for advertisement or promotion purposes.
- The Vendor will supply 1 or more raffle items worth at least \$15 upon their arrival.
